McDougald asserts that the court erred in giving this instruction. We think the instruction was proper. Such instructions have long been accepted by the courts. Wilson v. While general denials of guilt later contradicted are not considered exculpatory statements, any other exculpatory statement which is contradicted by evidence at trial justifies the giving of this jury instruction.
